What is the Qualified Lawyers Transfer Test?

The Qualified Lawyers Transfer Test (QLTT) is a conversion Test, which enables lawyers qualified in certain countries outside England and Wales, as well as UK barristers, to qualify as English solicitors. The Test is administered under the supervision of the Solicitors Regulation Authority (SRA), the regulation arm of the Law Society of England and Wales.

The QLTT is one of aptitude rather than memory and examinees are allowed to take into the Test any book, document or other written material. You also need to satisfy the examiners that your knowledge of the English language is at the standard required to practise as a solicitor in England and Wales. The pass mark is only 50%.

Eligibility

The QLTT is open only for those candidates who obtained or applied for a Certificate of Eligibility on or before August 2010. Candidates who did not apply or obtain their certificate before August 31, 2010, will not be able to take the QLTT and need to go through the new QLTS route. You must complete the exams and fulfill any outstanding requirements before the expiry of your Certificate of Eligibility.

Exam Format

The QLTT covers four main subject areas, also known as "Heads":

- Property (Head I)
- Litigation (Head II)
- Professional Conduct and Accounts (Head III)
- Principles of Common Law (Head IV)

Not all candidates are required to pass all four Heads of the Test. The number of Heads you must pass should be specified in your Certificate of Eligibility. Some candidates also need to satisfy the SRA that they have gained two years of Common Law experience within the past five years of which at least one year must have been gained by practicing the law of England and Wales.

You may choose the number of Heads you wish to take each time. In the event that you do not pass one Head, you can re-sit the test for that Head alone on any available date you choose.
